

## Quarterly Public Reporting for CARES Act (a)(1), CRRSAA (a)(4), and ARP (a)(4) Student Aid Portion (HEERF I, II, III)

This report is prepared to provide information about Alexander Paul Institute of Hair Design's use and distribution of Student Grant funds allocated in the CARES Act (a)(1), CRRSAA (a)(4), and ARP (a)(4) Student Aid Portion known as HEERF II and HEERF III respectively. After an initial report/public posting, a quarterly report will be posted no later than 10 days after each calendar quarter.

- 1. Certification and Agreement** - Alexander Paul Institute of Hair Design signed and returned to the Department of Education the Certification and Agreement and the assurance the institution has used the applicable amount of funds designated under the CARES Act (a)(1), CRRSAA (a)(4), and ARP (a)(4) Student Aid Portion programs to provide Emergency Financial Aid Grants to Students.
- 2. Funds Received** - The institution will receive or has received **\$132,597** (CARES Act: \$43,451 + CRRSAA: \$56,182 + ARP: \$32,964) from the Department pursuant to the institution's Certification and Agreement for Emergency Financial Aid Grants to Students under the CARES Act (a)(1), CRRSAA (a)(4), and ARP (a)(4) Student Aid Portion programs.
- 3. Funds Distributed** - The total amount of Emergency Financial Aid Grants distributed to students under the CARES Act (a)(1), CRRSAA (a)(4), and ARP (a)(4) Student Aid Portion programs for this quarter is: **\$20,000**
- 4. Estimated Number of Students Eligible to Receive Grants** - The estimated total number of students at the institution that are eligible to receive Emergency Financial Aid Grants to Students under the CARES Act (a)(1), CRRSAA (a)(4), and ARP (a)(4) Student Aid Portion programs is **14**.
- 5. Number of Students Who Received Grants** - The total number of students who have received an Emergency Financial Aid Grant to students under the CARES Act (a)(1), CRRSAA (a)(4), and ARP (a)(4) Student Aid Portion programs is **11**.
- 6. Methodology** - This section describes the method(s) used by the institution to determine which students receive Emergency Financial Aid Grants and how much they would receive under the CARES Act (a)(1), CRRSAA (a)(4), and ARP (a)(4) Student Aid Portion programs.

### CRRSAA (a)(4) and ARP (a)(4) Student Aid Portion

CRRSAA (a)(4) and ARP (a)(4) Student Aid Portion Methodology Summary: The institution identified 2 tiers of need for the grants with corresponding amounts called "Exceptional Need" (Pell eligible EFCs & those with extraordinary financial circumstances) and "Need" (EFCs not eligible for Pell, those utilizing need-based aid, & those with considerable financial circumstances). Grant amounts for Exceptional Need and Need are \$2,000 and \$1,000 respectively.

Students request a grant on the institution's provided form, and students are assigned a tier of need and grant award based on the request and information the institution has on file. Students can appeal and provide additional information to be included in a different tier. Students may appeal and provide information for consideration of an additional \$1,000 in the most exceptional and rare circumstances.
